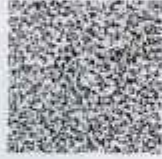




APPENDIX-IV


